**JUDGMENT**

This matter came on for trial by jury, the Honorable Paula A. Brown, Judge *Pro Tempore* presiding, on August 18, 19, 23, 24, 25, 26, 30 and 31, 2004 and September 1, 2 and 7, 2004. Present in Court were Cameron R. Waddell, Brian F. Blackwell and Steven M. Jupiter of **LEBLANC & WADDELL, LLP** representing the plaintiffs, Beatrice Joshua, Mary Lou Davis, Joyce Madison, Namon Joshua, III, Gerald Joshua and Farrell Joshua and Charlton B. Ogden of **TAGGART, MORTON, OGDEN, STAUB, ROUGELOT & O'BRIEN, LLC** and W. Scott Brown of **ENTERGY SERVICES, INC.** representing the defendant, Entergy Louisiana, Inc.

Judgment is hereby entered, in accordance with the Jury's answers to the Jury Interrogatories, as follows:

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiffs, Beatrice Joshua, Mary Lou Davis, Joyce Madison, Namon Joshua, III, Gerald Joshua and Farrell Joshua, and against the defendant, Entergy Louisiana, Inc., in the amount of **SIX HUNDRED SIXTY SIX THOUSAND SIX HUNDRED SIXTY SIX AND 66/100 (\$666,666.66) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under the plaintiffs' survival action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Beatrice Joshua, and against the defendant, Entergy Louisiana,

Inc., in the amount of **ONE MILLION SIX HUNDRED FIFTY THOUSAND AND NO/100 (\$1,650,000.00) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under her wrongful death action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Mary Lou Davis, and against the defendant, Entergy Louisiana, Inc., in the amount of **ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under her wrongful death action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Joyce Madison, and against the defendant, Entergy Louisiana, Inc., in the amount of **ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under her wrongful death action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Namon Joshua, III, and against the defendant, Entergy Louisiana, Inc., in the amount of **ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under his wrongful death action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Gerald Joshua, and against the defendant, Entergy Louisiana, Inc., in the amount of **ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00) DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under his wrongful death action.

**IT IS ORDERED, ADJUDGED AND DECREED** that there be Judgment in favor of the plaintiff, Farrell Joshua, and against the defendant, Entergy Louisiana, Inc., in the amount of **ONE HUNDRED FIFTY THOUSAND AND NO/100 (\$150,000.00)**

**DOLLARS** together with interest thereon, at the legal rate, from the date of judicial demand (June 12, 2001), until paid as damages under his wrongful death action.


**IT IS FURTHER ORDERED, ADJUDGED AND DECREED** that the defendant, Entergy Louisiana, Inc., be and is hereby cast with all court costs, including but not limited to expert costs associated with the trial of this matter.
